### ORDER

As per Government Orders read above, Government have revised pay and allowances of the faculties of Universities and Affiliated Colleges, Teachers in Law Colleges and Engineering Colleges, Teachers in Agricultural University, Veterinary & Animal Science University, Fisheries University, Technological University, Malayalam University, Faculties in Medical Education including Medical, Dental, Nursing and Pharmaceutical Sciences, Faculties in Ayurveda Medical Education, Faculties in Homeopathic Medical Education, Faculties in Govt./Aided Polytechnic Colleges, Teachers in Physical Education and Qualified Librarians etc in the state coming under the UGC/AICTE pay patterns, in accordance with 7<sup>th</sup> UGC/AICTE Schemes.

The above Government Orders contain directions regarding disbursement of arrears on account of pay revision on which, the installments of arrears are to be disbursed w.e.f 01/01/2023 onwards. But the reimbursement of central share of arrears from UGC/AICTE has not received yet due to some technical reasons. The present financial position of the state is also not conducive to disburse pay revision arrears.

In the above circumstances, Government hereby order that the installments of arrears on account of 7<sup>th</sup> Pay Revision under UGC/AICTE scheme to various categories of employees and teachers irrespective of their department/institution, which are due for payment from January 2023 onwards are withheld till the position of State finances improves or Government issues further necessary directions/orders in this regard.


